JOM Reflections

Are Restorative Practices operative in your local school - community-Family?

In June we were invited to share some ideas about restorative justice, especially in relation to restorative practices within families and schools. Pierre Flajole represented JOM at a meeting sponsored by First United Methodist Church in Farmington. An example cited by Pierre is implemented in the Hamtramck School system. Hamtramck Schools have implemented restorative practices. There is a trained Restorative Practices Coordinator in each school. The RP Coordinator is hired at each school and trained by the International Institute for Restorative Practices in Bethlehem PA. Restorative Practices is proven to reduce misbehavior, bullying, violence, crime, and improve the learning situation. An example from Hamtramck is a 15 year old Bengali boy. "I got into an altercation with another boy. We did a circle on how to restore the problem. We talked about what happened, then apologized and shook hands. Teachers and students and brothers and parents were there. Me and the other boy are friends now. Other schools just kick you out. " From JOM'S perspective, Pierre's presentation about the work of Restorative Practices is a meaningful expression of our Mission Statement. Thanks to Rev Carolyn Wik and her community for inviting JOM to participate in this meeting at her Church.

JOM Meets with Rabbi Michael Moskowitz



Rabbi Michael Moskowitz, President of the Board of Rabbis in Michigan and Rabbi of Temple Shir Shalom, West Bloomfield, MI accepted JOM's invitation to meet on April 17, 2012 with JOM representatives: Mary Beth Schniederman, Rabbi Ari Kostelitz, and Shirley Townsend. The JOM volunteers shared with Rabbi Moskowitz information about JOM mission and ministry and operations of jail and at outreach. In reflecting on needs, Rabbi Ari Kostelitz followed up with what he does to help Jewish inmates upon their

release and gave an example of how he invited a newly released inmate over to his home for a meal.

Rabbi Moskowitz shared with the JOM representatives more specific information regarding the Jewish Federation of Metropolitan Detroit which is the Detroit Jewish Community's central philanthropic organization with links to local Jewish social service agencies, camps and schools. Rabbi Moskowitz reassured us that he would take our information and concerns to share with the Board of Rabbis. All of us appreciated the opportunity to come together to strengthen our bond and collaboration, as well as, share our common concerns for victims, offenders, and families of both.

The high energy messages are intertwined with Biblical truth and life experiences from the field of football. They know that people are faced with decisions each and every day, and through the message of Christ, always challenge their audience to "Think Twice!" They met with small groups in Oakland County Jail during May.

Mike Smith, one of our volunteers in Jail & Outreach Ministry sums up their presentations in this way: "Guy and John Earle, through the Holy Spirit, moved men, women and young people to tears as they presented the powerful message of developing a personal relationship with Jesus Christ. We can make millions, be 'superstars', be on television, radio, in newspapers and the movies, but until we fill that emptiness - that 'void in the human heart' - in knowing Him, we are still unsatisfied and empty. Only after developing a relationship with Him, can we experience the very real and true joy of living and truly being alive. This is the message that was delivered to the men and women at the Oakland County Jail in Pontiac and to young people at a private juvenile services facility in Detroit.

These two men came from Texas for a weekend in May to share some of their life experiences that led them to Jesus in hopes of sharing with others so that they too could come to know Him. "

Forgiveness..."To

Clergy Clearance and Visiting Oakland County Jail

Clergy Clearance

The jail visitation desk uses the Directory of Churches prepared by the Metropolitan Christian Council as a basis for clergy entering the jail to visit a member of your faith community. Changes need to be updated through the Council 313-870-9550 or fax 313-831-2009 or e-mail: Councilweb@sbcglobal.net.

How/Why to get listed in the Directory of Churches? Many denominations and communions update all their church listings annually.

Other faith groups and denominations have to do the updating individually before October.

This usually becomes urgent when you are trying to visit a member in jail. Plan ahead. 313-870-9550

Tips on Security

- Send materials directly from publisher.
- No staples or hard back books allowed
- All Religious materials need to be cleared and delivered through the Chaplains' Office
- Bring Picture ID
- Be prepared to place all personal items in a locker

Clergy visiting a family member or relative

If you are visiting family/relatives, you are required to visit as a FAMILY MEMBER in a Jail Setting within FAMILY times and guidelines.

Professional Clergy listed in Directory of Churches Family Visitation is not the same as a professional visit with a member of your local church / faith community. If you are listed in the *Directory of Churches* you will only need to:

- check on inmate location
- cleray times for visiting.
